

ANNUAL VOLUNTEER ACKNOWLEDGMENT AND CERTIFICATION OF COMPLIANCE

The Ohio Association of SkillsUSA, Inc. I acknowledge that all such Exams are the exclusive property of the SkillsUSA Ohio and constitute confidential and proprietary information that shall not be disclosed.
5. In the event I receive confidential and proprietary information about the Exams, Award Programs, Leadership Events and Activities, students, or other matters, I agree to notify SkillsUSA Ohio immediately and agree to not disclose, directly or indirectly, to any person, any such confidential and proprietary information.
6. I understand that a violation of these provisions may result in disciplinary action against me, including but not limited to, notice to my employer, forfeiture of awards, and suspension from participating in Award Programs, Leadership Events and Activities and further action through the Ohio Department of Education Office for Professional Conduct if warranted.
7. I understand that violation of these disclosure provisions will cause irreparable harm to SkillsUSA Ohio for which monetary remedies may be inadequate, and that the SkillsUSA Ohio shall be entitled, without waiving other rights or remedies, to take all appropriate actions to remedy or prevent such disclosure or misuse, including obtaining temporary restraining orders and injunctions.

No course of dealing between myself and SkillsUSA Ohio, no waiver by SkillsUSA Ohio, and no refusal or neglect of SkillsUSA Ohio in exercising any rights under this Acknowledgment, or in enforcing compliance with the terms of this Acknowledgment, shall constitute a waiver of any provision of this Acknowledgment.
