<b>Location</b>	Delaware Area Career Center 4565 Columbus Pike Delaware, Ohio 43035	<b>Contest Time</b>	Immediately following orientation (CLOSED contest)
<b>Scope of Contest</b>	<p>This competition evaluates each competitor’s ability to give a speech on an assigned topic with a minimum of advance preparation. A three- to five-minute speech will be delivered with a preparation time of five minutes:</p> <ul style="list-style-type: none"> <li>• The technical committee will select a speech topic based upon material in the <i>SkillsUSA Framework Fundamentals Cards</i> and <i>SkillsUSA Member Handbook</i>. All competitors will be assigned the same topic.</li> <li>• Competitors will enter the preparation room, where they will be given a speech topic and will have five minutes to develop and organize the content of their speech.</li> <li>• During preparation time, competitors may consult reference materials supplied in the preparation room and may make notes on 3” x 5” cards for use during the speech. Competitors may not take any outlines, notes or reference materials into the preparation room.</li> <li>• The speech shall be at least three minutes in length but shall not exceed five minutes. <ul style="list-style-type: none"> <li>• Penalty: Five points will be deducted for each 30 seconds or fraction thereof under three minutes, or for each 30 seconds or fraction thereof over five minutes.</li> </ul> </li> <li>• Time limit: Time will be started when the speech begins. The timekeeper will signal the speaker at three minutes, four minutes and five minutes. Competitors will be permitted to use a watch or clock.</li> <li>• Competitors will not mention their name, school, city or state at any time in the presentation room. A five-point penalty will be assessed for each occurrence.</li> </ul> <p><b><i>Please see judging rubric at the end of the document.</i></b></p>
